### **PRI Wellness Corps**

PRI Wellness Corps is a partnership between Pamlico Rose Institute and AmeriCorps dedicated to advancing well-being through inclusive programming in community wellness gardens. These gardens meet people where they are—providing safe, welcoming spaces that promote healthy living, connection, healing, and growth. The PRI Wellness Corps supports garden sites across North Carolina, including its flagship wellness gardens in Aurora.

**Member Impact** 

Members have the opportunity to reach underserved and at-risk community members, promoting wellness through their service. Service focuses on mitigating food insecurity, fostering community connections, and providing opportunities to learn about and develop skills supporting healthy living.

#### **Essential Functions of Position**

- Provide necessary maintenance of the farm/ garden, including:
- Weeding, Watering, Pest Control (Organic approved only), Mulching
- Harvest, prepare, and deliver produce for market.
- Assist with inventory and record keeping.
- Interact with customers/clients in a manner consistent with the values of Peacehaven.
- Assist with direction and coaching of volunteer teams.
- Assist with programs, workshops, and other training activities on the farm.
- Use farm equipment in a safe, responsible manner.

## **Eligibility Requirements**

- At least 18 years old and a US Citizen
- Access to reliable transportation
- Pass background check (National Sex Offender Registry, State of Residence and FBI Fingerprint Checks)
- Preferred High School or GED Diploma

## **Commitment Required**

- Three-Quarter Time AmeriCorps Member Service Year, with 1200 hours of service expected over the service term (approximately 30 hours per week)
- Permits working at another job or attending school during non-service hours
- ·AmeriCorps gear provided and some gear must be worn during all service hours

### **Member Benefits**

- Living Allowance: \$625 bi-monthly, not to exceed \$15,000 for the service year
- Mental Health First Aid Training
- Other Professional Development Training Education Award (\$5,176.50 for three quarter time member role), which may be transferred to another person (e.g. child, grandchild) if the member 55 yrs of age or older
- May be eligible for loan deferment during the service term
- On completion of the service year, gain access to the AmeriCorps Alums national network (1+ million members); Non-competitive eligibility for employment; and receive consideration for employment by National Service agencies





#### **EEOC**
